The Green House model radically transforms the traditional long-term care facility into a supportive home environment that focuses on the needs of the individual rather than the operational needs of the institution. The structure of the Small House communities is necessary to fully realize person-directed care: creating meaningful life and a real home for elders, and to empower the workforce. This model not only supports the physical well-being of elders, but also their individuality and dignity.
