THE NEW JEWISH HOME, MANHATTAN, LOCATED AT 120 WEST 106TH STREET, NEW YORK, NY OPERATES A 514-BED FACILITY PROVIDING LONG-TERM SKILLED NURSING, POST ACUTE REHABILITATION, DEMENTIA CARE COMMUNITIES, ADULT DAY PROGRAMS, PAIN MANAGEMENT AND PALLIATIVE CARE, SOCIAL SERVICES AND RELIGIOUS LIFE AND PASTORAL CARE PROGRAMS. THE NEW JEWISH HOME, MANHATTAN HAS 38 BEDS IN MANHATTAN DEDICATED TO STATE-OF-THE-ART CARDIOPULMONARY REHABILITATION. IN ADDITION TO A FULL RANGE OF CARDIAC REHABILITATION, TREATMENT CAPABILITIES HAVE EXPANDED TO COVER PULMONARY CONDITIONS INCLUDING COPD, PRE AND POST LUNG TRANSPLANTATION, AND RESTRICTIVE LUNG DISEASES INCLUDING INTERSTITIAL LUNG DISEASE AND PULMONARY FIBROSIS.
